Finance report

Louis- operating on finance from 2023; I sent everyone a text \$ 21,800 capital; it was \$25,000; \$11,000 remanding in account, 2023 funds; \$57,586.86 transfer over Transfer on quarterly bases I will speak with the BA & CF. We used the left over money to pay for pension and catch up.

We need to start working better as a board and educate the city council; we are the least funded library in Essex County \$732,000 budget \$752,000 Our problem is City Council;

You got those notes just making sure they don't blame my Boss

I think we could discuss a strategic plan – internet system; board ban; capital and move forward. Ex: New York library built houses over the library urban areas; plan to move in directions of technology library, computers and above building units in the PNC building; opportunity for employees as well, additional revenue to come in Dan-specialize library
