Dave- we don't have a time line right now

Louis- these are goals for the next 3-5 years

Lydia- what about a Liberian

David- it's not in our budget right now but will in the near future

Louis- that's a civil service position

Lydia- why can't you train your staff to become a Liberian

Louis- civil service has a requirement and needs an education

Lydia- is there opportunity to go to school

David- they have to step up

Abosola- you said your strategic plan started since 2023

Louis – explaining how and when strategic committee came about

Shanella Palmer- training making the library more accessible and how do you help kids with special needs, can we get a date for all the assessment

**Trustee Concerns** 

Johnathan- Ms. Faye Louis- you can't talk about employees in the public Louis- Alice gave us something that the State require

Louis- extending the hours of the library including in strategic plan

David- the library hours should be 60

Alice- no it's based on the size

David- what's the state requirement

Alice- we need more staff numbers

Louis- we can make an advertisement for civil service

David- what staff we need for the children room

Alice- Liberian and assistance

David- who do you have as an assistance?

Alice- we have 4

David- do we need a monitor; what's a monitor?

Alice – it's like an assistance

David- what if we can bump someone up to an assistance

Alice- we need 3 assistance

David- if we do two separate shifts, will that be enough?

Alice- yes, it can work like that. The part time can work only 19 hrs. She's concern if she works more than 19 hrs. Also she can't work when it gets dark at night

Louis- we can only afford a Liberian, the city is working on less people and we will hve to do more with the people here. We will hire a Liberian and everyone else will have to increase their work if they want an increase

David- how many reference Liberian

Alice- 1 Liberian and 2 part times

David- Ms. Faye is back

Alice- ves

Johnathan- how many hours for part-time

Alice- no more than 19 hours; FT children, director and reference

Louis- budgeting for children Liberian new hours

Louis-hours has to be increase by the State, we haven't responded to their letter so we are out of compliance, we will send a letter

David- wrote Stephanie, we don't have a budget to increase time because we don't have the money.

Louis- did she talk to anyone of you and responded to letter Stephanie wrote

Johnathan- did they give us a time frame

Alice- they want a periodical

Louis- how much in the budget for periodical

Alice- need \$5,000, we have \$2,000

Louis- we will work that out, you need \$6,000

Alice- yes, \$3,000 (\_\_\_\_) and \$3,000 (electronic)

Louis- Full time employees 8

Alice- we have 9

Louis- State said we should have 8 employees we can split the assistance 2/2

Louis- we can look at extending our Liberian hours on Saturday to 5 pm

Theresa- that doesn't mean you have to be here

Alice- if the PT can't stay

Johnathan-hours; 10-9; 10-5:30;10-9; 10-5:30; 9-5pm

Dan-

David-time clock; when?

Louis- when will we do reduction of staff?

Johnathan- can we ask the city council to help with payment for security?

Louis- it's not their responsibility to help

David- I come every month talking about our security concern, we need to do a letter to city council and put it on the record that we ask.

Louis-\$731, 00 for this year; it's what we were funded with

Dan-consider a fund raiser, something that will pay for security

Louis- if we can get a class 3, we can pay them less

Theresa – people are just allow to come here and sit

David- yes, we can't put them out it's a public building; all I'm asking is that we be on the right side

Dan-let me ask a conflict resolution that we can take for the employee/public

Louis- reboot ach \_\_\_\_\_ cameras system \_\_\_\_ to police; security guard- special 25hrs a week and salary; Liberian it's noted we need more

Louis- budget stand point need to do budget contract for acting director on stipend (Alice act as though you're not in the room)

Louis- hire security guard immediately, what's your thought?

Alice-good

Louis- do we agree on security guard

Dan-larger issue pepper spray; how do we stop those from coming in the building, do we have a panic button in the library, what's the response time?

Louis- What's the cost to add a Liberian Alice?

Alice-\$50-\$60,000

Louis- let me work on some number

David- we have to get a time clock

Louis- City order new time clock and a request went to City if library could order a time clock

David- two employees outside not sure what's their lunch schedule

Theresa- do you have a lunch schedule for employees

Alice- yes

David- we need to put a committee today for CWA issue
